THIS WORK STRIVES TO CREATE A CULTURE OF LITERACY BY ENSURING THAT THERE ARE AN ABUNDANCE OF EQUITABLE OPPORTUNITIES FOR CHILDREN TO HARVEST FREE, CULTURALLY INCLUSIVE BOOKS WHEREVER FAMILIES GO, HELPING THEM BUILD HOME LIBRARIES AND A ROBUST HOME LITERACY ENVIRONMENT. BOOKS ARE PROVIDED THROUGHOUT THE COMMUNITY WITH FOURTEEN BOOK BOXES, SEVEN LAUNDROMATS, AND SEVENTEEN COMMUNITY BOOKSHELVES, AS WELL AS PROVIDING BOOKS ON AN OCCASIONAL BASIS TO 180 COMMUNITY PARTNERS. BOOK HARVEST'S FAMILY SPACE IS OPEN TO THE PUBLIC FOR STORYTIMES AND FREE BOOKS. THE ORGANIZATION ALSO HOSTS TWO LARGE-SCALE COMMUNITY EVENTS ANNUALLY: DREAM BIG ON MLK DAY AND THE SUMMER BLOCK PARTY. IN 2022, 179,292 BOOKS WERE DISTRIBUTED TO THE COMMUNITY THROUGH THESE EFFORTS.

AN EVIDENCE-INFORMED HOME VISITING PARTNERSHIP, BOOK BABIES PROVIDES SUPPORT TO ENROLLED FAMILIES THAT BEGINS WHEN A BABY IS BORN AND IS SUSTAINED OVER FIVE YEARS.
